# **2024 McAshan Summer Internship Award Application**

## **General Information**

The Program in Poverty, Justice, and Human Capabilities is pleased to open applications for the 2024 McAshan Summer Internship Program. Internships for 2024 may be in person, remote, or hybrid. All internships must be approved by the PJHC Director and the PJHC Program Mentor.

Successful applicants will receive an award of \$6,000, intended to cover a stipend plus reasonable expenses incurred as part of the internship. Additional funding may be available in special circumstances, such as for international internships, conditional on an approved budget. All funding is contingent upon successful completion of internship requirements and commitments.

Applications for the internship program will be reviewed upon receipt. Students admitted into the program must work with the PJHC Program Mentor to identify an appropriate internship placement. The Summer Service Internship Plan must be completed and submitted by Friday, February 23, 2024. Contingent on PJHC approval, all parties (the host organization, the student, and the PJHC) must sign a MOU to confirm the arrangement and expectations.

#### Eligibility requirements:

• Applicants must be declared or pledged PJHC minors, with priority given to declared minors. (The Registrar will only process Declaration of Minor forms for students who have previously declared their majors or who are doing so concurrently.)

• Applicants must have completed or be enrolled in PJHC 371

## Internship Commitment:

• Successful applicants must commit to work with the PJHC Program Mentor to identify and accept an appropriate internship placement and submit their internship plan by Friday, February 23, 2024.

• Successful applicants must agree to the PJHC Internship Commitments

To be eligible for selection, applicants must affirm the following commitments by checking the blank next to each item.

\_\_\_\_\_I have not previously received funding from the PJHC for a Susan McAshan Summer Service Internship.

\_\_\_\_\_I agree to be placed in service of a nonprofit organization that serves an under-resourced community or individuals. My internship will not be used for the purpose of direct proselytizing.

\_\_\_\_\_I will devote at least 75 percent of my time in my internship to direct community service that actively engages with those being served.

\_\_\_\_\_I will work at least 30 to 35 hours per week in the approved placement continuously for at least ten weeks. In all, I will work at least 300 hours.

In addition to service, I will study the structure and functions of the agency where I am placed so that I can assess the effectiveness of the organization in attaining its goals.

\_\_\_\_\_I will exhibit sensitivity to the host culture and laws, and abide by the philosophy, structure, and regulations of the host agency.

\_\_\_\_\_I will submit a thank you letter to donors at the end of the internship and no later than September 15, 2024.

\_\_\_\_\_I will complete a Digital Stories project as part of the capstone course, PJHC 470, and attend the Digital Stories event to present my Digital Story.
